As a Bible Club Worker, I agree to do my part to protect the children and fellow teachers by:

- Never allowing a child to be alone with me, another worker or adult during Bible Club time.
- Having at least three approved workers in each club.
- Encouraging children to use the restroom before or after club time.
- If necessary, only allowing approved adult Bible Club workers to give bathroom assistance.
- Designating a teacher to walk down to the restroom with the child and wait out in the hall.
- Having no one in the classroom unless he/she has received authorization prior to coming into the room.

- Keeping my hands in the "safety zones" when I am near the children so that none of my actions will be misunderstood. (Rule of thumb: Do not touch a child in areas that a bathing suit would cover.)
- Avoiding off-site one-on-one meetings.
- Avoiding one-on-one encounters that occur when other adults cannot see what is taking place.
